



## **YSF COVID WAIVER FORM**

I am the parent/legal guardian of the below named child. I have agreed to allow my child to participate in the Youth Spring Football Tournament of my free will and recognize that the game of contact football and/or cheerleading is a sport that may carry risk of bringing my child into contact with the Covid 19 Corona Virus. In consideration of this fact I agree to allow my child to participate in this spring football program. I recognize that YSF has implemented a full set of Covid protocols that may reduce the risk of serious illness and possible death, but the risk remains regardless, and as the undersigned I acknowledge and agree that:

- Participation in the YSF spring tournament may include possible exposure to the infectious disease namely COVID-19 resulting in possible sickness and maybe death to myself, my family or my children.
- I knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the other parents/coaches/administrators and players or others, and/or the YSF tournament and assume the full responsibility for my participation.
- As mentioned above YSF provides a full Covid protocol that is posted on the YSF website <http://youthspringfootball.com/docs/YSF-Covid-Protocols.pdf> and I agree to abide by the items detailed in this protocol. If, however, I observe any deviations from the protocol I will remove myself and my child from the activities and inform the YSF management of my concerns.
- I commit to undertaking the items within this protocol that pertain to me and my child and implement them as closely as possible.
- I commit to informing YSF management and/or my team's Covid Director any time my child has been exposed to or infected by the covid virus. I will also remove my child immediately from all YSF tournament activities for a period of 10 days of quarantine.

For and in consideration of my child being permitted to participate in the YSF tournament activities, I hereby voluntarily release, discharge, waive and relinquish any and all claims or actions for damages for personal injury, permanent disability, death, or property damage which I or my child may have, or which may hereafter accrue to me or my child, as a result of my participation in the YSFL Football tournament activities or while I am at the facility while others play or for any other reason. This release is intended to discharge, in advance, YSF, its officers, employees and agents, and the owners and maintainers of any facility used for the activities, from any and all liability arising out of or connected in any way with my child's participation in practice, pre game, or game tournament activities, even though that liability may arise out of negligence or carelessness on the part of YSF, its officers, agents or employees.

**I have fully read this Covid Waiver Form, and fully understand its terms, that I give up substantial rights by signing it, and sign it voluntarily for both my child and myself and do release the YSF Tournaments from any and all liabilities, even if arising out of YSF negligence.**
